## When would I use the NCEA website?

**If you’re a teacher**, you might use this to plan programmes that engage students in the not-to-be missed learning in a subject or wāhanga ako, and to carry out NCEA assessments.

**If you’re a head of department, faculty, learning area, or wāhanga ako**, you might use this to guide your team in planning coherent, learning-focused courses, and to plan how you will incorporate assessment opportunities to suit your local context.

**If you’re a leader of a school or kura**, you might use this to understand the aims of the NCEA Change Programme so that you can align your kura or school’s strategic direction, to build a shared understanding in your community, and to keep up with NCEA updates and news.

## NCEA co-requisite resources

You can learn more about the new co-requisite, including what you need to know about the 2024-2025 transitional period before the changes are required.

From 2024, the te reo matatini, pāngarau, literacy and numeracy skills requirements of the NCEA are formally separated out from the certificate at Levels 1-3, and the 20-credit co-requisite becomes mandatory. A two-year transitional period in 2024 and 2025 provides schools, kura, and all NCEA providers with time to adjust.

School-wide approaches to foundational te reo matatini, pāngarau, literacy and numeracy skills can be strengthened during the transitional period. You can learn more about the co-requisite standards and find resources to help on our website:

### When would I use the te reo matatini, pāngarau, literacy and numeracy resources?

**If you're a teacher**, you might use these resources to help to build the skills into your teaching and learning programmes and support students who are working towards the attainment of the co-requisite.

**If you're a head of department, faculty, learning area, or wāhanga ako**, you might use these resources to develop a team-wide strategy on improving the teaching and learning of these skills across subjects and learning areas.

**If you're a leader of a school or kura**, you might use these resources to develop school-wide strategies to support student learning and attainment.

## Planning Guide

This one-page poster walks you through what resources are useful at different stages of your planning, and helps you navigate the NCEA website to find what you need.

You can use it to better understand:

- the way the new NCEA Level 1 fits with the National Curriculum
- the learning matrix for your subject, or tukutuku ako for your wāhanga ako
- how to plan your course outlines
- the new Subject Learning Outcomes documents for NZC subjects
- the new Ngā Putanga Ako for Te Marautanga o Aotearoa wāhanga ako
- the different Achievements Standards or Paerewa Paetae for your subject or wāhanga ako.

### When would I use the planning guide?

**If you're a teacher**, you might use this to understand how the new NCEA materials fit together, what they are for, and where to find them.

**If you're the head of department, faculty, learning area, or wāhanga ako**, you might use this to ensure your team uses the right materials and resources at the right time.

**If you're a leader of a school or kura**, you might use this to lead the development of a shared understanding of the new NCEA materials with students, teachers, and whānau, and to inform school PLD.

### When would I use the teacher-only day resources?

**If you're a teacher**, you might use this bank of resources to find subject-specific materials to support your planning.

**If you're a head of department, faculty, learning area, or wāhanga ako**, you might use this to support your team to develop their understanding of the refreshed NZ Curriculum, Common Practice Model, Kaupapa Māori and Māori-medium settings, or NCEA, and how they apply to your context.

**If you're a leader of a school or kura**, you might use this to revisit any of these areas that your school community may need to spend more time on for their learning and development.

**If you're a teacher**, you might use these resources to support you to conduct valid assessments, and to make assessment judgements.

**If you're a head of department, faculty, learning area, or wāhanga ako**, you might use these resources to check your department's assessment programmes, practices and resources meet all of the requirements set by NZQA

**If you're a leader of a school or kura**, you might use these resources to ensure that the assessment offered across your school or kura
