- the influence of the major factors on the health issue
- the impact of the major factors on well-being.

The in-depth analysis is supported by detailed evidence.

Analyse, perceptively, involves recommending strategies based on a coherent explanation that connects the international health issue, and the influence of the major factors on the issue, to relevant underlying health concepts (hauora, socioecological perspective, health promotion, and attitudes and values).

The perceptive analysis is supported by the coherent and consistent use of evidence.

- 3. An international health issue is one currently affecting the well-being of an identified community or sector in a country (or countries), and which is a matter of public concern. Health-related issues may be derived from:
 - culture and gender
 - sexual and reproductive health
 - disease
 - immunisation
 - life expectancy
 - drug use
 - colonisation and the health of indigenous peoples
 - globalisation and health.
- 4. Factors that influence a health issue could include:
 - economic considerations
 - social norms
 - policy decisions
 - location.
- 5. Supported by evidence refers to the use of specific and relevant details to support an analysis. Supporting evidence may include examples, quotations and/or data from credible and current sources such as government ministry websites, recognised nongovernment organisations (NGOs), research journals, and other publications. Generally, current research means data or theories published within the last five years.
